


Overview

ANNUAL REPORT

January 2018

The GBBC Annual Report is a comprehensive overview of the state of blockchain technology, including a global regulatory analysis, updates on ICOs and identity issues, and a look at some of the most innovative applications of blockchain technology around the world. Our Work - Events

DAVOS, SWITZERLAND January 2018

Returning to the World Economic Forum Annual Meeting, the GBBC hosted "Blockchain Central" - hosting 14 events, including panels on everything from global trade to identity, key networking events, a waiting-listed 200-person dinner, and bringing together global leaders to talk about #blockchain and its current and future benefits to society.

Additionally, we partnered with SurveyMonkey to find out just how much the U.S. knows about digital currencies & blockchain. One interesting finding: Only 5 percent of people own bitcoin, but an additional 21 percent say "they are considering adding it to their portfolios."











Our Work - Advocacy

BRUSSELS, BELGIUM

October 2017

On October 18th, in partnership with Eva Kaili, MEP, the GBBC hosted a discussion on EU Engagement with blockchain technology and the implications of emerging technologies on the global economy in the EU Parliament. There were over 100 attendees — including Members of European Parliament, representatives from the EU Commission and senior executives from the corporate and blockchain communities.

NECKER ISLAND, BVI July 2017

Fifty leaders representing the business, technology, government, academia, arts and non-profit sectors gathered on Sir Richard Branson's Necker Island to discuss blockchain technology for the 3rd annual "Blockchain Summit." Hosted by the full-service blockchain company Bitfury and its board member, venture capitalist Bill Tai, with special support from Chong Sing Holdings Group and the Global Blockchain Business Council. this year's summit featured attendees from around the globe. While many blockchain events are dominated by men, nearly half of the summit attendees were women. Attendees included Greek European Parliament member Eva Kaili, English singer Imogen Heap, renowned Peruvian economist Hernando de Soto. May 2017 & 2018

During the Annual Berkshire Hathaway Shareholders Meeting weekend, the Global Blockchain Business Council (GBBC), in partnership with the **Greater Omaha Chamber**, hosted a blockchain event focused on business solutions and the role of technology in the future economy across sectors. The GBBC curated and moderated 13 blockchain sessions - including standing-room only panels, daily "Blockchain Information Sessions," and one on one briefs for stakeholders from around the globe.

BEIJING & SHANGHAI, CHINA March 2017

Events surrounding the opening of the GBBC in China took place in concert with the Annual China Financial Literacy Conference. The Conference focused on blockchain and Fintech and the roster of speakers for the GBBC China launch events included Niall Ferguson, Scottish historian and professor; Madame Xiaoling Wu, Vice Chairwoman of Financial and Economic Affairs Committee of National People's Congress; Wang Wei, Founding Chairman of China Mergers and Acquisitions Association (CMAA); Yew Kiat Phang, Vice Chairman & CEO of Chong Sing Holdings Group; Hernando de Soto, world-renowned economist; Valery Vavilov, CEO of The Bitfury Group; Liu Mingkang, Distinguished Fellow at the Institute of Global Economics and Finance and former Chairman of the China Banking Regulatory Commission; Yulu Chen, Deputy Governor of the People's Bank of China; Yongqiang Sheng, Vice-President of Shanghai High People's Court; Bill Tai, Co-Founder of MaiTai Global, and many others. Events had more than 1,500 people in attendance.




