Water-free: The unit will be air cooled neither consuming nor producing wastewater


Clean air: No NOx, SOx, or particulate

Climate proof: 97% of all CO₂ generated is captured


Flexible: Ramping capability with energy storage

The Supercritical CO₂ Allam-Fetvedt Cycle



The biggest, baddest battery (non toxic)




Supports up to two days of battery storage, which is amongst the best batteries in the world




Key Points

- The Tribe and 8 Rivers have identified an 18-acre brownfield site on which Red Cedar Gathering Company owns and operates oil and gas facilities.
- The proposed site serves as an ideal location for Allam-Fetvedt deployment for various reasons
 - Existing natural gas pipeline infrastructure can provide a consistent stream of natural gas feedstock
 - Proximity to transmissions lines supports offtake of electricity for 3rd party customers
 - Offset to CO₂ pipelines operated by Red Cedar and another midstream infrastructure company
 - The site is classified as an Opportunity Zone under the Tax Cuts and Jobs Act of 2017, allowing for substantial tax benefits


Coyote Clean Power Location and Infrastructure
