Vicki Hollub is President and Chief Executive Officer of Oxy. She has been a member of Oxy's Board of Directors since 2015.

During her more than 40-year career with Oxy, Vicki has held a variety of management and technical positions with responsibilities on three continents, including roles in the United States, Russia, Venezuela and Ecuador. Before her appointment to President and CEO, she served as Oxy's President and Chief Operating Officer, overseeing the company's oil and gas, chemical and midstream operations. Vicki previously was Senior Executive Vice President, Oxy, and President, Oxy Oil and Gas, where she was responsible for operations in the U.S., the Middle East region and Latin America. Prior to that, she held a variety of leadership positions, including Executive Vice President, Oxy, and President, Oxy Oil and Gas, Americas; Vice President, Oxy, and Executive Vice President, U.S. Operations, Oxy Oil and Gas; Executive Vice President, California Operations; and President and General Manager of the company's Permian Basin operations. Vicki started her career at Cities Service, which was acquired by Oxy.

Vicki serves on the boards of Lockheed Martin and the American Petroleum Institute. She is a member of the Oil and Gas Climate Initiative and past chair of the World Economic Forum's Oil and Gas Community. A graduate of the University of Alabama, Vicki holds a Bachelor of Science in Mineral Engineering. She was inducted into the University of Alabama College of Engineering 2016 class of Distinguished Engineering Fellows and elected to the National Academy of Engineering Class of 2024.

INTERNATIONAL PARTNER OF THE YEAR AWARD

Hellenic Energy Exchange S.A.



In recognition of our joint efforts to integrate Southeast Europe electricity networks and markets with Europe, Hellenic Energy Exchange S.A. has been selected to receive the USEA International Partner of the Year Award for 2025. HEnEx, part of EnExGroup, has helped Greece establish itself as an energy leader in the region.

Beginning in 2023, USEA and HEnEx collaborated on a federally-funded project to accelerate electricity market connectivity between Western Balkan and European Union countries. That integration—which is still underway—

is happening through a process called "market coupling," which optimizes regional transmission network activity by reducing the complexity and cost of cross-border electricity trade. Ultimately, market coupling attracts investment because it provides price transparency.

Market coupling also advances the clean energy transition. Currently, the Southeast Europe region's energy markets are small, reliant on aging fossil fuel-based power plants and a limited number of energy suppliers. For countries of the Western Balkans, in particular, expanding electricity market integration with neighbors and with the European Union will improve access to shared resources and optimize investments in new generation and grid improvements.

HEnEx's expertise was particularly valuable to the project's non-EU participants—Albania, Kosovo, and North Macedonia. To be successful at market coupling, these countries must first align with EU energy policies. USEA and HEnEx supported each country's transmission system operators, market operators, and national regulatory authorities in restructuring their internal operations and protocols in accordance with EU market rules and principles, while simultaneously developing legal agreements with EU counterparts.

Sarah McKinley MANAGER OF INTERNATIONAL VISITS FEDERAL ENERGY REGULATORY COMMISSION (FERC)

Sarah McKinley has served as a public information specialist with the Federal Energy Regulatory Commission for over 20 years, focusing on international visits, organizing technical conferences and serving as a liaison with the public.

Before joining FERC she spent over 20 years in various capacities in the energy industry. She was a consulting associate for The E Cubed Company,

LLC of New York, specializing in policy issues that relate to distributed generation and demand response markets. She also served as the first Executive Director of the Distributed Power Coalition of America, from 1998 through 2000. In that capacity she guided the organization's rise in national prominence, on both a state and national level.

Prior to that she spent over 13 years as an energy journalist covering FERC, federal courts, Congress and the markets. For 10 years during that time, she founded and directed the development of Gas Mart, a leading energy conference and trade fair. She also created maps and educational materials for the natural gas industry that have become industry standards.

During her tenure at FERC, Sarah McKinley played a pivotal role in strengthening global energy governance by facilitating over 50 visits for foreign delegations hosted by USEA. She personally engaged with delegations of electricity officials from developing countries, providing them with a comprehensive understanding of FERC's mission, structure, and regulatory authority. Sarah illuminated FERC's critical role in ensuring fair and transparent energy markets, overseeing interstate electricity transmission and natural gas pipelines, and enforcing reliability standards to maintain grid stability.

By connecting these delegations with key FERC officials and subject matter experts, she enabled them to glean valuable insights into regulatory best practices, market-based energy reforms, and the integration of renewable energy into competitive markets. The lessons learned from these visits equipped officials with strategies to enhance market transparency, improve regulatory frameworks, and foster investment in their own countries' power sectors —contributing to more efficient, reliable, and sustainable energy systems worldwide. Through her meticulous coordination of logistics and content, Sarah ensured that each delegation left with actionable knowledge tailored to their nation's specific energy challenges and aspirations.

Sarah will be retiring on May 31. USEA wishes her well and a wonderful retirement!
